## Only Lake Membership applicants need continue...

Application and payment for Lake membership must be post marked by June 16 to allow sufficient time for *volunteer* Membership Secretary to process and mail lake passes and boat stickers.

Payments and applications post marked **AFTER June 16** will incur a **\$10 LATE CHARGE**. Member will be denied use of Lake until member receives passes (up to two weeks after membership fee and late charge are paid).

To owners seeking Lake privileges for their renters:

**Monthly renters are eligible** for lake privileges only if the **owner** of house they are renting has applied for membership and **made full payment** (\$250) for that house. Renters and residents of Smallwood who are residing in a home that is not on membership roll will not be admitted to Lake as a guest.

**Renters** of homes for a period of **less than a month** are **not eligible** for Lake membership. Home owners who give their lake pass to such renters are subject to lose their lake privileges. Home owners must include monthly renters name, address & phone number on this form. Lake passes will be made out and mailed to the renters. Renter Lake passes are imprinted with a red ® on face of card.

## 2012 Application for Boat Stickers

The following must be agreed upon in order to receive a sticker required for boating on the Lake.

1. Owner of boat must be a Lake member, or a house guest of a member, and have a lake pass available for presentation to volunteer Lake Patrol all times whilst on Lake or surrounding property.
2. Gasoline powered boats are forbidden.
3. Per New York State law, all boats powered by an electric motor must be registered with the state.
4. Per New York State law, there must be **one personal flotation device** for **each adult in boat and children** under age 12 **must wear a personal flotation device** at all times.  
 Children under 18 years old must be accompanied in the boat by an adult (age 18+).  
*Exception:* Children carrying proof of New York State approved boat safety certification.  
 For safety reasons, you may be approached by volunteer Lake Patrol to confirm compliance with the above.
5. Number of people in boat shall not exceed the maximum capacity.
6. As a convenience to its Lake members, the Civic Association offers free boat storage on its Lake property. The Civic Association is not responsible for theft or damage of any type to such boat.
7. All boats stored on Lake property must have a current sticker affixed to it no later than July Fourth (if unable to do so, contact [lakepatrol@smallwoodcivicasociation.org](mailto:lakepatrol@smallwoodcivicasociation.org)). Thereafter, boat may be confiscated. A \$25 removal and storage fee will be collected before such boat is released to owner.
8. Inflatable boats do not need stickers affixed *unless* stored on Lake property.
9. Anyone using an inflatable boat on Lake must have sticker available for presentation to volunteer Lake Patrol at all times.
10. No boats may be stored or used in designated swimming area.
11. Stickers are not transferable and may only be affixed to boat herein described.
12. Any violation of above rules is grounds for a sticker to be revoked. The Board of Directors will review the reason and determine the duration of time the sticker is to be revoked for.
